5. Registration (alternative application) and Payment Information

Registration (Application) is complete as soon as you have completed and sent us the application form. The deadline is 31 May 2018. Fees are listed on the first page of this application form.

(a) Application by 15 March 2018 for the entire Summer School Program

You can take advantage of our €500 early bird discount. If you take the early bird discount, you pay only an initial €500, due by 15 March. The remainder of €1.990 must be paid by 30 June 2018.

(b) Application between 15 March and 31 May 2018 for the entire Summer School Program

If you submit your application between 15 March and 31 May 2018 you need to make an initial payment of €1,000 by 31 May. The remainder of €1,990 is due by 30 June, 2018.

(c) Application till 31 May 2018 for One or More Block/s of our Summer School Program

Payment of the respective amount (€1,000; €1,200; €1,500) has to be made by 30 June 2018.

6. Cancellation and Refund

(1) Cancellation by the student

All cancellations must be made in writing by the following deadlines:

- 30 June: full refund minus € 1,000.00 administration fee
- after 30 June: no refunds can be made

(2) Cancellation by the Hochschule der Sparkassen-Finanzgruppe

Registration (application) will be rejected if the payment is not made by the respective deadline and the partial payment (deposit) will be kept as an administrative fee.

(3) Cancellation of the Summer School

- We reserve the right until 31 May 2018 to cancel the Summer School Program 2018 if there are not enough participants (minimum: 15).
- If the Summer School Program 2018 has to be cancelled at short notice due to extenuating circumstances, the Summer School Program cannot be considered completed nor is there compensation. Fees paid in accordance with (5) will be refunded. Other expenses (i.e. flights, visa, etc.) will not be refunded.
