Exact departure times for excursions will be communicated a few days before. Exams for the individual courses will be written every Saturday. Our fee includes: learning documents, lecturers, lessons, excursions, lunch, insurance (health, liability, accident) and a public transport ticket for the Cologne/Bonn region. Flight prices, airport transfer, visa, accommodation costs, all other meals and diverse individual costs are not included in our fee.
